SECTION II: SCOPE OF THE TENDER

II. DESCRIPTION

II. 1.1) Name given to the tender by the contracting authority:

I. 1.2) Brief description:

ANAS calls an international competition, with an open procedure, divided into two phases pursuant to art. 109 of Legislative Decree 163/06 and subsequent amendments and supplements, aimed at the realisation of a design project for the definition and design of a type of "**overpass**" to be used for the various possible junctions present on the network; the **first phase**, for the technical proposal, carried out in anonymous form, is aimed at selecting the best design proposals up to a maximum of **10** (ten) to be admitted to the subsequent phase; in the **second phase**, in **non-anonymous** form, the best design project from those selected previously (max. of 10) will be chosen.

The area of reference for verifying the application of the "*concept*" and the development of the project - **selected from among the *Main routes included in the ANAS Multiannual Plan 2015-2019*** - will be chosen, at the end of the first phase of the competition, from among the ANAS works which include a good series of different types of intersection with the roads affected, to be resolved through the use of overpasses. The maximum cost of the design proposal for the type of "overpass" for individual infrastructures including ramps and associated elements must be equal to:

- € 1,500,000.00 (excluding VAT and foundation work) for ordinary overpasses;
- € 3,000,000.00 (excluding VAT and foundation work) for junction overpasses.

Before proceeding to the second phase, which entails the application of the concept and the development of the project in the area of reference to be chosen, the maximum cost of the works will be estimated.

Assessment during both the first and the second phases will be made based on the average of the scores, ranging between zero and one, allocated at the discretion of each member of the selection panel; once the procedure for awarding discretionary scores is complete, the average of the scores allocated to each bid by all the panel members will be transformed into final scores, giving the highest average a value of one and attributing such maximum average in proportion to the provisional averages previously calculated.

Further specifications on the award criteria and relative scores will be indicated in the **Competition Regulations**.

IV.3) CRITERIA APPLYING TO THE ASSESSMENT OF PROJECTS

Proposals will be assessed according to the corresponding weightings below:

Phase 1 of the Competition:

- Quality and recognisability of the project as regards the architectural, functional aspects and its applicability to different territorial situations (max. 50 points);
- Integrated approach to energy and sustainability issues in the proposal submitted (max. 30 points);
- Quality of the proposal in terms of accessibility and connections with the surrounding areas (max. 20 points).

Phase 2 of the Competition:

- Quality of the project in terms of composition/architecture, its recognisability and unique features (max. 30 points);
- Technical feasibility of the application of the design proposal in the different physical environmental, human and functional conditions present on the ANAS network; analysis of economic impact of the various possible applications (max. 25 points);
- Functional organisation of spaces for the insertion of technical-functional elements in the infrastructure (max. 10 points);
- Accessibility, connections/integration with the surrounding fabric as regards its relationship with the natural environment and the design of green areas (max. 10 points);
- Effectiveness of the communication project for shared development and public participation in the design solutions (max. 10 points);
- Use of highly innovative materials and devices related to the reuse and recycling circuits of materials: they will also be evaluated for their ability to minimize routine and / or extraordinary maintenance, including in relation to the ready availability thereof and ease of installation (max. 10 points);

- Engineering works and artistic-architectural **features** to be placed in the vicinity and / or in the areas pertaining to the overpass and its road links (max. 5 points).

Assessment during both the first and the second phases will be made based on the average of the coefficients, ranging between zero and one, allocated at the discretion of each member of the selection panel; once the procedure for awarding discretionary scores is complete, the average of the scores allocated to each bid by all the panel members will be transformed into final coefficients, giving the highest average a value of one and attributing such maximum average in proportion to the provisional averages previously calculated.

The winner of the competition will receive the amount of € 150,000.00 (gross of VAT and provident fund) as a prize for the proposal and design submitted.

The competitor coming second will receive the amount of €. 75,000.00 (gross VAT and provident fund) and the third classified the amount of €. 50,000.00 (gross VAT and provident fund). Each of the following seven (7) competitors will be awarded a lump sum refund of €. 1,500.00 (gross VAT).

VI.2) ADDITIONAL INFORMATION;

- a) The tender procedure will be carried out through a Request for Proposals in a sealed digital envelope (online Request for Proposals). **Under penalty of exclusion** the required documentation must be sent exclusively online, competitors who are not yet registered on the ANAS Purchasing Portal should therefore proceed to register on the portal <https://acquisti.stradeanas.it> to be able to send the required documentation online. Competitors are therefore invited, if not yet registered, to complete their registration on the aforementioned portal as soon as possible in order to send all the required documentation within the deadline established, in the manner and as required by the Competition Regulations.

To such purpose, **registration must be made within 7 (seven) days prior to the deadline for the submission of tenders as in point IV.4.3. above.** After such date, registration cannot be guaranteed.

It should be specified that **registration is a prerequisite for participation in the Competition and is free of charge.**

To enter the competition, competitors must have the minimum computer equipment indicated in the section of the ANAS Purchasing Portal called "Verifica la configurazione HW e SW" (Check the hardware and software configuration) accessible from the home page of the Portal <https://acquisti.stradeanas.it>.

In order to ensure the authenticity and integrity of documents, as well as to complete the online bid, the legal representative of the design company or professional competitor must equip itself in advance with a valid digital signature certificate, issued by a body from the list of public certifiers held by the AgID - former DigitPA (provided for by art. 29, paragraph 1 of Legislative Decree 82/05) generated by a device for the creation of a secure signature, pursuant to the provisions of article 38 paragraph 2 of Presidential Decree 445/00 and by art. 65 of Legislative Decree 82/05 and subsequent amendments and supplements and by the Prime Minister's decree 30 March 2009 (OJ 6/6/2009 no. 129).

Digital signature certificates issued by the following bodies are allowed:

- Certifiers operating under a license or authorization issued by a Member State of the European Union and meeting the requirements of Directive 1999/93 / EC of the European Parliament and Council "on a Community framework for electronic signatures."
- Certifiers established in a non-EU Member State where one of the conditions set out in paragraph 4 of art. 21 of Legislative Decree no. 82/2005 is met.

Such digital signature certificate must be used to sign the documents required hereunder and by the Competition Regulations.

Please note that the only accepted formats of digital signatures are CADES and PADES.

The digital signature of a compressed folder (e.g. .zip) containing one or more unsigned documents (where required) is not permitted.

Deeds and documents not digitally signed (where required), or signed with a digital signature certificate other than as required above will not be deemed valid and effective and will therefore result in exclusion from the Competition.

In case of temporary groupings or consortia to be formed or EEIG, all the documents submitted must be signed in handwriting by all the legal representatives or by the agents of all the companies wishing to form a group, and digitally only by the legal representative of the future group leader, again according to the specific procedures set out in the Competition Regulations; in the case of groupings or consortia already constituted or of EEIG, wherever a scanned copy of the irrevocable, collective mandate with representation granted to the representative or a scanned copy of the deed of memorandum of the Consortium or the EEIG contract is attached to the application, the said application and its annexes may be digitally signed by the legal representative or special agent of the representative or group leader.

- d) In the event of pooling, the candidate must enclose the documents required by art. 49, paragraph 2 of Legislative Decree 163/06 and subsequent amendments and supplements. **Under penalty of exclusion**, the auxiliary entity must make a declaration regarding the possession of the general requisites pursuant to article 38 of Legislative Decree 163/2006 and subsequent amendments and supplements. The aforesaid statements must be made in the same manner described for the competitor.
- e) Should only one valid bid be submitted for this Competition, ANAS SpA reserves the right, pursuant to art. 55, paragraph 4, of Legislative Decree 163/06 and subsequent amendments and supplements, to proceed with the award provided that the bid is, at its sole discretion, considered appropriate and affordable.
- f) Any requests for clarifications concerning this Notice of Design Competition must be sent, after registration on the ANAS Purchases portal <https://acquisti.stradeanas.it> using the Message feature of the Request for Proposals online.

Replies will only be made to requests for clarification regarding this Notice of Competition received no later than **17/03/2016**. **The questions and relative clarifications relating to this Notice will be published on the ANAS Purchase portal <https://acquisti.stradeanas.it> and on the website at <http://www.stradeanas.it>**

Such replies will be deemed as received by competitors from the time of publication and the contents accepted with the sending of the online bid containing the required documentation.
